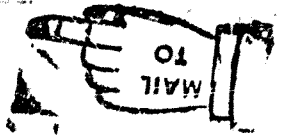

2ND AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS AND COVENANTS FOR HIDDEN LAKES ESTATES CONDOMINIUM PALOS HILLS, ILLINOIS

SC 5-46-57

THIS 2ND AMENDMENT TO CONDOMINIUM DECLARATION made and entered into this 27 day of October, 1982, by and between Palos Bank and Trust Company, as Trustee under Trust Agreement dated December 1, 1979, and known as Trust #1-1574 ("DECLARANT"), Palos Bank and Trust Company, as Trustee under Trust Agreement dated July 17, 1979, and known as Trust #1-1504 ("TRUST 1504"), American National Bank and Trust Company of Chicago, as Trustee under Trust Agreement dated May 8, 1981, and known as Trust #52713 ("TRUST 52713"), American National Bank and Trust Company of Chicago, as Trustee under Trust Agreement dated July 16, 1981, and known as Trust #53328 ("TRUST 53328"), Columbia National Bank of Chicago, as Trustee under Trust Agreement dated July 6, 1981, and known as Trust #1440 ("TRUST 1440") and Columbia National Bank of Chicago, as Trustee under Trust Agreement dated July 6, 1981, and known as Trust #1459 ("TRUST 1459") (all except DECLARANT collectively hereinafter referred to as "THE TRUSTS").

WHEREAS, DECLARANT, by Declaration of Condominium ("DECLARATION") recorded in the Office of the Recorder of Deeds, Cook County, Illinois as Document #25439399, submitted certain real estate to the provisions of the Illinois Condominium Property Act ("the ACT") and created the Hidden Lakes Estates Condominium ("CONDOMINIUM"); and

WHEREAS, the DECLARATION reserves the right to annex and add to the parcel and property (as defined in the DECLARATION) and thereby add to the CONDOMINIUM created by the DECLARATION all or any portion of the Additional Land (as defined in the DECLARATION); and

WHEREAS, by 1st Amendment to Condominium Declaration dated the 25th day of June, 1981, and recorded in the Office

of the Recorder of Deeds, Cook County, Illinois as Document #25925710 Additional Land was added to the CONDOMINIUM; and

WHEREAS, the DECLARANT wishes to add Additional Land to the CONDOMINIUM and amend a provision of the DECLARATION; and

WHEREAS, TRUST 1504 is the legal title holder to the property described in Exhibit "C"; and

WHEREAS, TRUST 52713 is the legal title holder to the property described in Exhibit "D"; and

WHEREAS, TRUST 53328 is the legal title holder to the property described in Exhibit "E"; and

WHEREAS, TRUST 1440 is the legal title holder to the property described in Exhibit "F"; and

WHEREAS, TRUST 1459 is the legal title holder to the property described in Exhibit "G"; and

WHEREAS, the DECLARANT and THE TRUSTS now desire to so annex and add to said parcel and property and submit to the provisions of the ACT and the DECLARATION the real estate owned by THE TRUSTS and described in Exhibits "C", "D", "E", "F" and "G" (the ADD-ON PROPERTY), which ADD-ON PROPERTY is the portion of the said Additional Land which was previously described in Exhibit "C" of Document #25439399.

NOW THEREFORE, the DECLARANT and THE TRUSTS do hereby amend the DECLARATION as follows:

1. The ADD-ON PROPERTY is hereby annexed to the parcel and property as defined in the DECLARATION and is submitted to the provisions of the ACT as part of the CONDOMINIUM in accordance with and shall be deemed to be governed in all respects by the terms and provisions of the DECLARATION.

2. Exhibit "A" of the DECLARATION is hereby amended by adding Page A-1 and Pages 11 through 16, which are attached hereto to the original Exhibit "A".

3. The percentage of ownership in the common elements appurtenant to each unit as set forth in Exhibit "B" to the original DECLARATION, is hereby shifted to the percentages set forth in Exhibit "B" which is attached hereto.

4. Exhibit "C" of the DECLARATION is hereby amended and replaced by Exhibit "H" attached hereto.

5. Article VIII, Section Q of the DECLARATION, is amended on Page #23 to insert the words "or by deed in lieu of foreclosure" after the word "mortgage" in Line #2 of the first full Paragraph on Page #23.

6. All the unit owners by DECLARANT, their attorney-in-fact, hereby consent to this Amendment to Declaration, pursuant to the power and provisions set forth in Article VII of the DECLARATION.

7. The additional common elements annexed by this instrument are hereby granted and conveyed to the Grantees of all units, including the Grantees of units heretofore conveyed, all as set forth in the original DECLARATION.

8. Except as expressly set forth herein the DECLARATION shall remain of full force and effect in accordance with its terms.

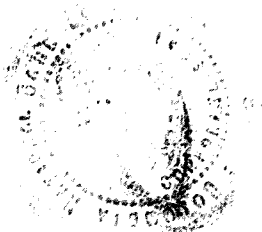
